REPORTS

President's Report (Bob Bedoll)

- 2020 taxes were discussed and reviewed by AIHS board
- Bob's projects:

Pierce County Health Department is allegedly closed for permits. The decision was made to cancel the Salmon Bake based on the current situation. Salmon Bake delivery options discussed included working with the Riviera or Barbara. Also, could possibly do the Salmon Bake on Labor Day weekend. Obviously, there is no way the State of Washington could possibly reverse itself and open things up. However in the unlikely circumstance that the State might open things up, this subject can be revisited (Secretary's note these minutes were written with the benefit of hindsight).
